TRUTH IN TAXATION NOTICE

Executive Director Risinger read the Public Hearing Notice that was published in the Daily Herald newspaper on Thursday, December 2, 2021:

**NOTICE FOR PROPOSED PROPERTY TAX INCREASE
FOR BUFFALO GROVE PARK DISTRICT**

- I. A public hearing to approve a proposed property tax levy increase for Buffalo Grove Park District for 2021 will be held on December 13, 2021 at 6 pm at 530 Bernard Drive, Buffalo Grove, Illinois.

Any person desiring to appear at the Public Hearing and present testimony to the taxing district may contact Ryan Risinger, Secretary, 530 Bernard Drive, Buffalo Grove, Illinois at (847) 850-2122.

- II. The corporate and special purpose property taxes extended or abated for 2020 were \$7,262,556.

The proposed corporate and special purpose property taxes to be levied for 2021 are \$8,311,313. This represents a 14.44% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2020 were \$1,767,841.

The estimated property taxes to be levied for debt service and public building commission leases for 2021 are \$1,803,346. This represents a 2.01% increase over the previous year.

- IV. The total property taxes extended or abated for 2020 were \$9,030,397.

The estimated total property taxes to be levied for 2021 are \$10,114,659. This represents a 12.01% increase over the previous year.


Commissioner Reiner moved to close the public hearing at 6:02 pm, seconded by Vice President Bragg and passed with a voice vote.
